INSTRUCTIONS TO TENDERERS

(With reference to the prepa	ration and submission of Tenders for the Services of articles referred
to in the attached schedule)	(WASHERMAN)
To:	

- 1. Sealed tender for the services shown in Appendix <u>'A'</u> will be received by the Principal, Cadet College Choa Saiden Shah Chakwal upto <u>1030</u> hrs on 15th June 2022. Tender must be sent under a strong cover distinctly marked Tender for <u>"WASHERMAN"</u> contract, and addressed to "Principal Cadet College Choa Saiden Shah Chakwal".
- 2. Tender received late will not be entertained.
- 3. Rates once quoted will not be enhanced during the contract period.
- 4. All the tenders are to be attested with full signatures of the Tenderer. Any alteration / cuttings must be authenticated by the Tenderer signatures separately.
- 5. Each tender must be accompanied by earnest money as per enclosed appendixes in the Form of call deposit receipt made in the name of <u>"Principal, Cadet College Choa Saiden Shah Chakwal"</u>. The old contractor need not deposit money as his security is already held by the College. Earnest money shall be refunded to unsuccessful Tenderer.
- 6. Cheque shall not be acceptable.
- 7. The tenderer must attach CDR of earnest money @2% of Bids Amount along with Tender form. After issuance of offer letter, acceptance of contractor shall be required to sign the agreement separately on stamp paper worth Rs. 2000/-.
- 8. Contractors will abide by the orders and instructions issued from time to time.
- 9. Available suitable accommodation in the premises will be provided to the contractor. No advance will be given. Electric Bill/ Shop Rent will be charged.
- 10. The contractor, before the expiry of the agreement, will not be permitted to give up the contract. In case he does so he will forfeit his security deposit. The College authorities, reserve the right to terminate the contract without any notice, in case the services of the contractor are not found satisfactory. The decision of the Principal in this matter will be final and legally binding on the contract. The Principal reserves the right to terminate the contract immediately on disciplinary or any other grounds. The Principal will be the sole judge in such cases.
- 11. If a contract is awarded to a contractor, and later he does not turn up to execute the contract, the amount of earnest money deposited by him will be forfeited.
- 12. Contractor would also be required to make their goods and services available to the College employees at the rates approved by the Principal, the rates of such goods and services when approved would be displayed at the shops.

- 13. Income tax will be deducted from the bill at the prescribed rates.
- 14. The contract can further be extended for one year, if the rates remain same depending on quality of service provided by the contractor and other terms and conditions of the agreement.
- 15. Those persons/firms are eligible to apply who have working experience in the same field.
- 16. The Tenderer must attach 6 months Bank Statements, CPR's of Income Tax and GST (If Applicable) and 2 years Income Tax Returns.
- 17. Attached copies CNIC, Income Tax, Provincial Sales Tax (PST) and GST (If Applicable) Registration Certificates.
- 18. The committee is not bound to accept the lowest tender. Decision of selection / Purchase Committee will be final and not challengeable in any court of law.
- 19. Quality of served items can be decided by the Selection/Purchase committee.
- 20. Committee has the right to approved or cancel the tender according to the PPRA Rules.
